The institution namely **Motherhood Institute of Management and Technology, Plot Number-394, Village-Karondi, Post office-Bhagwanpur, Tehsil/Taluka-Roorkee, Town/city-Haridwar, District-Haridwar-247661, State-Uttarakhand** was granted recognition vide NRC, NCTE order No. **F. NRC/NCTE/F-3/NRCAPP-1042/201<sup>st</sup> Meeting/2012/27272-278 dated 31.07.2012** with an annual intake of 100 seats from the academic session 2012-13 for the B.Ed. course of one year duration with an annual intake of 100 (One Hundred only) students, and a revised order was issued to the institution vide order No. F. No. NRC/NCTE/NRCAPP-1042/ 2015/105009-13 dated 26.05.2015 for conducting B.Ed. programme of two year duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to fulfillment of the conditions mentioned in the order before 31.10.2015.

The institution vide letter dated 15.7.2015 requested the NRC, NCTE to consider and permit the institution to run B.Ed. course from the Motherhood University, Roorkee, Uttarakhand (established under Uttarakhand Govt. Act No. 5 of 2015) instead of Sri Dev Suman Uttarakhand University, Tehri Garwhal, Uttarakhand.



**The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.**

- ***The institution is permitted to run the institution under Motherhood University, Roorkee, Uttarakhand.***

Therefore, the affiliating body of the institution namely **Motherhood Institute of Management and Technology** shall be the Motherhood University, Roorkee, Uttarakhand (established under Uttarakhand Govt. Act No. 5 of 2015) instead of Sri Dev Suman Uttarakhand University, Tehri Garwhal, Uttarakhand from the session 2015-16 onwards.
