ORDER

WHEREAS, the institution namely Motherhood Institute of Management & Technology, E-36, Industrial Area, Upper Road, Haridwar, Uttarakhand was granted recognition for B.Ed. course with an annual intake of 100 (One Hundred only) students vide order no. F. NRC/NCTE/F-3/UR-41/ 5098-5107 dated 05.07.2005 with an annual intake of 100 seats w.e.f. 28th June, 2005 read with corrigendum vide order No. F.NRC/NCTE/F-3/UR-41/6087-6096 dated 20.07.2005. The recognition of the institution was withdrawn vide order No. F.NRC/NCTE/F-3/UR-41/2009/10612-10618 dated 25.09.2009. Aggrieved upon the decision the institution filed a court case before the Hon'ble High Court of Uttrakhand at Nanital and the decision taken by the NRC was stayed by the Hon'ble High Court vide order dated 14.09.2009. Subsequently on the basis of the stay order of the Hon'ble High Court a revised order was issued to the institution vide order No. F. No. NRC/NCTE/UR-41/2015/117335-339 dated 18.06.2015.

AND WHEREAS, an application for shifting premises for B.Ed. submitted by the institution on 12.07.2015 received in NRC office on 20.07.2015 and the matter was considered by the NRC in its 240th meeting held from 20th to 22nd July, 2015 and the Committee decided that VT be constituted to verify the infrastructure & Instructional facilities created by the Institution for B.Ed. course as per NCTE Regulations, 2014.. Accordingly, a VT was constituted vide this office letter dated 14.09.2015

AND WHEREAS, the VTR was carefully considered by NRC in its 243rd Meeting held from 28th to 30th September, 2015 and committee decided that:-

> "The institution is permitted to shift its premises and change of name, but before that the Institution may be asked to submit an undertaking on stamp paper of Rs.100/- to the effect that it has obtained disaffiliation from the affiliating body, it was affiliated earlier and henceforth it will be affiliated to the Motherhood University, Haridwar, Uttrakhand"

Accordingly, a letter was issued to the Registrar, Motherhood University, Roorkee, Haridwar, Uttarakhand on 13.10.2015 for compliance of the above direction of the NRC, NCTE.

AND WHEREAS, the institution submitted its reply vide letter No. MHU/Reg./NCTE-2015-16/39 dated 23.10.2015 along with the requisite undertaking.

NOW, therefore, the NRC after considering all aspects allows the shifting of premises from Motherhood Institute of Management & Technology, E-36, Industrial Area, Upper Road, Haridwar, Uttarakhand to Faculty of Education, Co-Ed. Division, Madan Mohan Malaviya Campus, Motherhood University, Village-Karoundi, Post-Bhagwanpur, Tehsil-Roorkee, District-Haridwar, Uttarakhand and change of name of the institution as Faculty of Education, Co-Ed. Division, Madan Mohan Malaviya Campus, Motherhood University, Village-Karoundi, Post-Bhagwanpur, Tehsil-Roorkee, District-Haridwar, Uttarakhand and also permitted for affiliation to Motherhood University, Village-Karoundi, Post-Bhagwanpur, Tehsil-Roorkee, District-Haridwar, Uttarakhand from Hemwati
