This collaboration aims to leverage the strengths and resources of both parties to foster academic excellence, support healthcare initiatives, and enhance opportunities for students, faculty, and professionals.

I. INSTITUTION'S RESPONSIBILITIES UNDER THIS MoU

The Institution agrees to undertake the following responsibilities:

1. Provide necessary support to promote books published with SCRMP's publication house, leveraging institutional resources to maximize outreach and recognition for authors.
2. Collaborate with SCRMP to establish the multidisciplinary journal, assisting in outreach efforts to encourage submissions from university members and external contributors. Ensure timely dissemination of information regarding the article processing charges (INR 299 for university members and INR 899 for non-university members).
3. Make available indoor and suitable venues for conducting workshops and mass interactions as part of the collaboration. Ensure a balanced 50-50 contribution with SCRMP in terms of work, team, patron sharing, speaker allocation, and financial support for the events.
4. Encourage students from relevant programs to enrol in internships offered by SCRMP in domains such as journals, CRO, Pharmacovigilance, Medical Writing, and HEOR. Provide administrative support to registered society members for successful internship participation and completion.
5. Ensure SCRMP visibility (logo, acknowledgement, or promotion) in all events, activities, or projects that receive sponsorship contributions from SCRMP.
6. Establish a reporting mechanism for adverse drug reactions (ADRs) or events, ensuring that this information is regularly submitted to SCRMP's platform. Facilitate quarterly sharing of ADR data with SCRMP and assist in compiling reports for submission to health authorities.
7. Collaborate with SCRMP to integrate ADR reporting and other healthcare-focused initiatives as part of the institution's life sciences programs, enhancing educational and professional benefits for students.

II. SCRMP RESPONSIBILITIES UNDER THIS MoU

- We give Book publication a 50% waiver in our publication house. (100% Royalty)
- Hybrid Book Publication is also possible without any fees (30% Royalty)
- One journal Multidisciplinary Free of-cost establishment By society academic publisher (for university members 299 INR APC (article processing charge), non-university members need to pay 899 INR, and the amount will both divided equally whatever comes from APC model.
- Make available the infrastructure facilities, an indoor and suitable venue conducive for mass interaction/workshops. (it should be 50 - 50 percent collaboration in terms of work contribution, team contribution patrons sharing, speaker sharing and finance sharing)





- Internship in our journals, CRO, Pharmacovigilance, Medical Writing, HEOR. After completion of the internship will provide Offer Letter, LOR and Certification. (only for registered society members)
- SCRMP visibility should be there when we give sponsorship (any amount)
- ADR (adverse drug reactions plus events) should be reported on our website and the same information will be shared with the university quarterly wise and will submit these details to health authorities as a healthcare professional. (Benefit for life-sciences programmes)

III. PERIOD OF MoU

This MoU will be effective from for one year and can be renewed automatically for subsequent terms of one year, subject to mutual consultation. Either Party may terminate the MoU with one month's notice, as outlined in Article VI.

IV. CONFIDENTIALITY

Both Parties shall not use or cause the use of any Confidential Information for any purpose whatsoever other than those contemplated under this MoU. Both Parties shall use all reasonable endeavours to ensure that all persons to whom Confidential Information may be disclosed in furtherance of the MoU, including but not limited to officials and employees of both the Parties as well as students thereof, keep the same confidential and not use the same except for the purpose for which disclosure is made and with prior written consent from the other Party.

V. RESOLUTION OF DISPUTES

Any dispute arising during the period of the MoU shall be amicably resolved by good faith and trust ethically between the Parties, without involving any third person, agency legal practitioner etc.

VI. TERMINATION OF THE MoU

Any Party may terminate this MoU maintaining a termination notice period of one month. The right of termination for cause with immediate effect remains unaffected for each Party.

VII. ADDITIONS/DELETIONS ETC

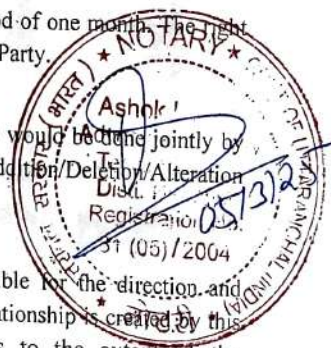

VIII. INDEPENDENT PARTIES

Institute and SCRMP are independent contractors and shall be responsible for the direction and compensation of their respective employees. No partnership or agency relationship is created by this MoU. This MoU creates only principal-to-principal relationships to the extent of the provisions of this MoU.

IX. SUCCESSION AND ASSIGNMENT

This MoU shall inure to benefit and bind the Parties hereto and their respective successors and assigns.





X. FORCE MAJEURE

Neither Party shall be liable for delay or failure in the performance of any of its obligations under this MoU when such delay or failure arises from events or circumstances beyond the reasonable control of such Party including without limitation acts of God, fire, flood, war, sabotage, communications, material changes in applicable laws which are general within commerce or labour disputes.

XI. GENERAL

Any other services or expert advice that falls outside the purview of the MoU as discussed if required will be agreed upon based on mutual consultations between the Parties.

This MoU imposes no financial obligations on either of the Parties. All pending issues or anything not covered by this MoU are to be settled mutually by the Parties to the satisfaction of each other.

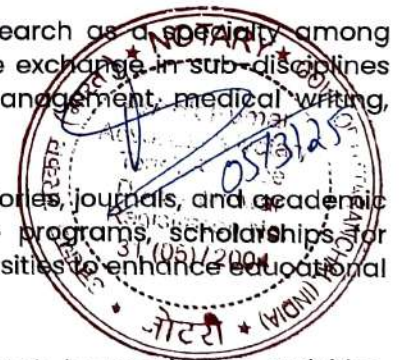

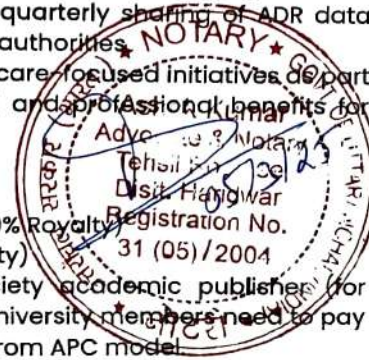
