## Memorandum of Understanding (MoU)

BETWEEN

Faculty of Pharmaceutical Sciences, Motherhood University, Roorkee,  
Haridwar, Uttarakhand-247661

AND

Vishnu Institute of Pharmaceutical Education and Research, Sangareddy-Narsapur Rd, Narsapur,  
Tuljaraopet, Telangana- 502 313.

**For the purpose of promoting academic, research, and cultural cooperation.**

This Memorandum of Understanding (MoU) is made on this 12<sup>th</sup> day of April, 2025, by and between Faculty of Pharmaceutical Sciences, Motherhood University, Roorkee, Haridwar, Uttarakhand - 247661 (herein after referred to as the "First Party"), and Vishnu Institute of Pharmaceutical Education & Research, Sangareddy-Narsapur Rd, Narsapur, Tuljaraopet, Telangana- 502 313. (herein after referred to as the "Second Party"). Both parties, for the purpose of this MoU, shall collectively be referred to as "the Parties."

### WHEREAS:

The First Party is Faculty of Pharmaceutical Sciences, Motherhood University, Roorkee, Haridwar, Uttarakhand- 247661. A State Private University, established under the Uttarakhand Government Act No. 05of2015, with the courses engaged in Pharmaceutical Sciences teaching, research, and extension activities.

The Second Party is Vishnu Institute of Pharmaceutical Education & Research, Sangareddy-Narsapur Rd, Narsapur, Tuljaraopet, Telangana- 502 313., involved in academics & research in Pharmacy

The purpose of this MoU is to establish a collaborative relationship between the University and the College to promote academic, research, and cultural cooperation.



## AREAS OF COOPERATION:-

### 1. BOTH PARTIES AGREE TO COOPERATE IN THE FOLLOWING AREAS:

- A) **Student Exchange Programs:** Facilitate the exchange of undergraduate and graduate students.
- B) **Faculty Collaboration:** Encourage joint research, teaching, and professional development opportunities.
- C) **Joint Research Activities:** Collaborate on research projects of mutual interest.
- D) **Curriculum Development:** Partner in the development and enhancement of curricula.
- E) **Workshops and Seminars:** Co-organize conferences, workshops, and training programs.
- F) **Resource Sharing:** Share academic resources, such as libraries, laboratories, and online platforms.

### 2. ROLES AND RESPONSIBILITIES

#### I. University Responsibilities

- Provide necessary guidance and support for collaborative activities.
- Facilitate access to facilities and resources for the agreed projects.
- Coordinate communication and planning for joint initiatives.

#### II. College Responsibilities

- Identify suitable students and faculty for participation in collaborative programs.
- Offer support to visiting University personnel.
- Ensure adherence to the agreed terms for any shared resources or projects.

### 3. Terms and Duration

This MoU is effective from the date of signing and remains in effect for the duration of 3 years, unless terminated earlier by mutual agreement.

The MoU may be renewed or amended upon written agreement by both parties.

### 4. Financial Arrangements

Each party shall bear its own costs unless otherwise agreed upon in specific agreements related to joint activities.

### 5. Dispute Resolution

Any disputes arising under this MoU will be resolved through mutual consultation and negotiation between the parties.

6. Termination

- Either party may terminate this MoU by providing a written notice of duration of 90 days to the other party.
- This MoU becomes effective from the date it is signed by both parties and shall remain valid for one year, extendable up to five years.
- The MoU will be reviewed at the end of each period (Three years) to determine whether modifications are needed. It may be amended by mutual written agreement between the parties and can be terminated by either party with three months' written notice.
- All ongoing activities at the time of termination or expiration will continue under the existing terms until completed.
- No amendment shall be valid unless agreed to in writing by authorized representatives of both parties.
- IN WITNESS WHEREOF, the parties have executed this MoU and represent that they approve, accept, and agree to its terms.
