**Sub:** Recognition of your University and extension of approval of affiliation to Faculty of Legal Studies, Motherhood University, Roorkee, Haridwar, Uttarakhand for imparting three year LL.B and five year BA LL.B law courses with an intake of existing two sections alongwith two additional sections i.e. total four sections of 60 students in each section in both the law courses subject to payment of guarantee amount of Rs. 5 lakh.

Sir,

Legal Education Committee at its meeting held on 30<sup>th</sup> July, 2016 considered the above mentioned subject. After consideration, Committee made the following recommendations: -

The Legal Education Committee considered the inspection report of Department of Law, Motherhood University, Roorkee, Haridwar, Uttarakhand and further, Committee is of the view that as per Section 7 (1) (i) of the Advocates Act, 1961 University be granted recognition for the purpose of conferring the degree of law for imparting three year and five year law courses and also granted extension of approval of affiliation for running LL.B three year course with intake of existing strength of two sections along with two additional sections i.e. total of four sections of 60 students in each section and five year BA LL.B course with existing strength of two sections along with two additional sections i.e. total four sections of 60 students in each section for a period of three years i.e. for the academic years 2016-2017, 2017-2018 and 2018-2019 subject to the following conditions :-

Since, the recognition of this new university has been given. As per rules, it has to deposit guarantee amount which is Rs. 5,00,000/- which is a pre-conditions for approval as aforesaid. The Motherhood Institute of Management and Technology, Roorkee is also allowed to be as a Department of Law of the Motherhood University, Roorkee.

Further, there is no legal aid clinic which should be constructed within three months and made workable as embodied under Rule 11 and 18 of Schedule III of Legal Education Rules 2008.

There is no toilet which should be constructed separately for boys, girls and staff within three months with intimation to the Bar Council of India within the same period.

1. The college management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008.
2. College should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.
3. The institution is directed to upgrade the library by investing minimum Rs. 10 lakhs per year.
4. The institution is also directed to upgrade the library by subscribing 10 sets of Indian Bar Review, selected judgments and professional Ethics published by Bar Council of India Trust.
5. Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.

College should also maintain the timing which has to be minimum 5 1/2 hours with half an hour break. College to file an affidavit to the Bar Council of India within six weeks mentioning the timing of the classes. The relevant rules are quoted hereunder :-

**Rule (xxiii), Chapter I**

“(xxiii) “Regular Course of Study” means and includes a course which runs for at least five hours a day continuously with an additional half an hour recess every day and running not less than thirty hours of working schedule per week.”

**Rule 5 of Schedule III**

“Classes may be conducted between 8 a.m. to 7 p.m. in an Centre of Legal Education, which is not fully residential. However the Library may remain open till 10 p.m.”

Institution should submit affidavit in compliance to the above conditions within six weeks.

College authorities are also required to apply to the Bar Council of India for further extension of approval six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2018 in respect of **three year LL.B and five year BA LL.B** law courses.

The above recommendations were considered by the Bar Council of India at its meeting held on 13<sup>th</sup> August, 2016 and approved the same.

This is for your information and necessary action.
